Eligibility Criteria for Vendors

1. Trade Tax registration certificate.
2. Authority letter of the manufacturer should be enclosed. The vendor must have experience of dealing & providing services of various equipments.
3. Original technical literature should be attached.
4. Rates & Specifications quoted should be valid for a minimum period of three months.
5. Three years on-site warranty period.
6. Tenders without the earnest money (2% of the total amount quoted) shall not be considered. The earnest money will be only in the form of DD in favour of Finance Officer, C.S.J.M. University, Kanpur.
7. The University reserves the right to reject any/all tender(s) without assigning any reason.
8. Tender should be strictly submitted in the format provided (as per proforma enclosed).
9. If the scheduled date of tender opening is holiday or due to any other reason if it is not possible to open the tenders; then in that case tenders shall be received and opened on next working day at the same time and place.
10. The University does not pledge to accept the lowest or any other tender and reserves the right not to accept the whole / any portion of tender as it may think fit without assigning any reason for non-acceptance/selection or reject of all tenders without assigning reason thereof.
11. The tender documents once submitted will not be returned back.
12. Conditional offers shall not be entertained in any case.
13. Subletting the work is strictly prohibited and also the operating staff shall maintain discipline and work ethics.
14. Any dispute with respect to tender document shall be referred to Vice Chancellor whose decision will be final.
15. The rates quoted should be inclusive of all taxes. University will not pay any insurance, packing charges or any other expenditure.
